### Oxurion Receives Transparency Notification from Atlas Special Opportunities LLC

Leuven, BELGIUM – July 18, 2024 – 06:00 PM CET - [Oxurion NV](#) (Euronext Brussels: OXUR), a biopharmaceutical company headquartered in Leuven, today announced that, pursuant to Belgian Transparency legislation<sup>1</sup> it has received a transparency notification as follows:

Oxurion received a transparency notification on July 17, 2024, from Atlas Special Opportunities, LLC indicating that as of July 17, 2024, it held 941,611,204 shares of the then outstanding 12,275,690,851 shares, and therefore crossed below the threshold (10%) by virtue of the sale of voting securities.
